Please read the following Terms and Conditions of Account Wager ("Terms and Conditions") carefully.

This Agreement describes the terms and conditions applicable to your use of the account wagering services provided by Lone Star Park. By using our wagering system, you accept all of the terms and conditions contained herein. The use of LSP Bet is subject to all applicable State and Federal regulations.

ACCOUNT INITIATION REQUIREMENTS

To establish and/or maintain a permanent wagering account, applicant must:

- Must be at least twenty one (21) years old.
- Provide the following personal information: Full legal name, phone number, email address, mailing address, a valid identification number and any other information that may be required.
- Have read and agreed to abide by all of the Terms and Conditions set forth by LSP Bet.
- Notify LSP Bet immediately regarding any change of personal information such as telephone number and address.
- Acknowledge that LSP Bet reserves the right to report unusual or suspicious activity to the proper authorities.

Only one account per verified person will be allowed. Lone Star Park at Grand Prairie reserves the right to reject any application for an account for any reason it deems necessary. Lone Star Park also reserves the right to close or suspend an account for any reason it deems necessary. If Lone Star Park deems it necessary to close or suspend an account, any remaining balance will be returned to the account holder.

The wagering account is for the exclusive personal use of the named customer account holder only. No other person may wager or otherwise access the wagering account. The customer account holder agrees to notify Lone Star Park immediately of any unauthorized use of a customer wagering account, password, PIN or a registration profile.

Wagering accounts may not be opened or used in any way for any illegal or improper purpose, including but not limited to:

- Evading any reporting requirements;
- Performing or hiding any criminal or illegal activity;
- Bribery/gratuity, check fraud, credit/debit card fraud, embezzlement/theft, unusual use of checks or wire transfer or false or conflicting ID(s);
- Attempting to wager on an event you cannot or are not supposed to wager on (such as a wager by or one behalf of a participant in the event such as a jockey);
- Activity that does not represent legal gambling activity or does not have a valid business or lawful purpose; or
- Activity that otherwise appears to be suspicious or not within normal wagering activity.

Account Procedures:

Wagering

LSP Bet allows you to wager in person at Lone Star Park or on a mobile wagering account using a personal mobile device.

Lone Star Park reserves the right to refuse any wagering transaction for any reason.

Deposits

The following types of deposits will be accepted in person for deposit into a wagering account:

- Cash
- Winning tote ticket or voucher.

OTHER NOTICES OF INFORMATION

Tax Reporting and Withholdings

In keeping with all Federal Tax Laws set forth by the Internal Revenue Service (IRS), any wager that results in winnings of \$600 will be reported to the IRS, if the amount of winnings is at least 300 times the original amount wagered. Any wager resulting in winnings over \$5,000, is subject to reporting and withholding if the amount of winnings is at least 300 times the original amount wagered. When required, Lone Star Park will report and withhold winnings. A Form W2-G will be sent to the account holder summarizing such activity. Note that a Social Security number or your W2-G information is not required to use LSP Bet and that any wager that falls under the criteria above will be "frozen" until you provide the appropriate W2-G information at an IRS window.

ACCOUNT SAFETY, SECURITY AND PLAYER RESPONSIBILITIES

Accounts are for the personal use of the account holder. The account holder is responsible for maintaining the secrecy of the Username, Password, Account Number and secure Personal Identification Number (PIN). Lone Star Park is not responsible for any loss arising from the use by any other person of an account holder's account. The account holder must immediately notify Lone Star Park of a breach of the account's security.

As an LSP Bet account holder, you can help minimize account problems or issues by:

- 1. Always keeping your User Name and Account Number in a safe, reliable place that is easily accessible to only you;
- 2. Memorizing your Personal Identification Number and Password, and keeping a backup in a safe and secure place;
- 3. NEVER leaving any device logged on to LSP Bet for any reason (always sign out when leaving your device unattended for any amount of time); and
