**Booth Space:** Lone Star Park at Grand Prairie will provide a 10-foot by 10-foot area for your convenience on Sunday, May 12, 2018. 10 x 10 area will be located in our Courtyard of Champions and can be accessed through the Courtyard gate. Vendors may set up beginning at 10:00 a.m. on Saturday, May 12, 2018 and must be ready prior to gate opening at 1:00 p.m. All vehicles must exit the loading area at the Courtyard gate and relocate to our General Parking lot (free of charge) by 12:30 p.m. Vendor booths must be open and manned from 1:00 p.m. to 5:00 p.m. Vendors may begin break down at 5:00 p.m. Vendors may bring and set-up a 10 x 10 tent with **prior approval** from Lone Star Park. Any approved tent must be secured properly with weighted objects and approved by Lone Star Park Security prior to gate opening.

**Security:** Lone Star Park will have a security guard in the Courtyard of Champions area at all times per our standard operating procedure but will not be responsible for lost or stolen items should you leave your space unattended at any time during operation.

**Restrictions:** Vendors will not be permitted to "roam" the facility and must instead remain within the boundaries of their booth space. The selling of food, drinks, balloons, projectile objects, bubbles, blow-up toys, glow products (including but not limited to glow necklaces, glow bracelets, and glow sticks) and any "lighted" products (anything with a light) is not permitted in Lone Star Park. In the event any vendor or vendor representative is found selling any prohibited items, that vendor is subject to removal from Lone Star Park at Grand Prairie without notice, compensation or reimbursement/refund of booth space rental fees.

**Payment:** Cash, Check or Money Order accepted. Payment must be secured by 5 p.m. on Friday, May, 4, 2018 to guarantee booth space during the event. Once payment has been received by Lone Star Park, there will be no refunds for any reason.

**Misc.:** Lone Star Park at Grand Prairie is not responsible for any stolen or lost items. Further, Lone Star Park at Grand Prairie, at its sole discretion, has the right to refuse service to any vendor who violates these rules or becomes unruly, its decision to be final.
