Weights: Three Year Olds, 118 lbs. Older, 123 lbs. Non-winners of \$30,000 in 2019 allowed 2 lbs.; \$15,000 in 2019, 4 lbs.; \$10,000 since November 1, 2018, 6 lbs. Maiden and claiming races not considered in allowances. Starters to be named through the entry box by the usual time of closing. High weights preferred (on the scale). Total earnings in 2018-2019 as determined by the information provided by Equibase Company, will be used in determining the order of preference of horses assigned equal weights. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.
