If less than ten horses start, the purse money not distributed will revert to the winning owner. Weights: Three Year Olds, 117 lbs. Older, 123 lbs. Non-winners of \$90,000 at a mile or over in 2019 allowed, 2 lbs.; \$60,000 since November 1, 2018, 4 lbs.; \$30,000 in 2018-2019, 6 lbs. Maiden and claiming races not considered in weight allowances. Starters to be named through the entry box by the usual time of closing. Highweights preferred (on the scale). Total earnings in 2018-2019, as determined by the information provided by Equibase Company, will be used in determining the order of preference of horses assigned equal weights. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.
