Maiden and claiming races not considered in weight allowances. Starters to be named through the entry box by the usual time of closing. High weights preferred (on the scale). Total earnings in 2020-2021, as determined by the information provided by Equibase Company, will be used in determining the order of preference of horses assigned equal weights. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.
