Supplemental nominations may be made at time of entry in the amount of \$9,000 and shall include all fees. \$300,000 guaranteed of which \$165,000 to the owner of the winner, \$57,000 to second, \$30,000 to third, \$17,250 to fourth, \$8,250 to fifth and \$4,500 for placing sixth through tenth. The \$100,000 additional for an Accredited Texas-Bred to be distributed \$60,000 to owner of the winner, \$20,000 to second, \$11,000 to third, \$6,000 to fourth, \$3,000 to fifth for an Accredited Texas-Bred finishing in that awarded position. Weights: 124 lbs. First preference will be given to highest lifetime earnings in order Grade I, II, III Stakes. Second preference to highest lifetime earnings. Lifetime earnings will be determined according to statistics provided by Equibase. This race will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. If less than ten horses start, the purse money not distributed will revert to the winning owner. Starters to be named through the entry box by the usual time of closing. A trophy will be presented to the winning owner.
