<p><b>NUTRENA STAKES</b> \$35,000 guaranteed – 400 yards 3-year-olds (AQHA Challenge enrolled horses preferred)</p>
<p><b>WRANGLER STAKES</b> \$35,000 guaranteed – 350 yards 2-year-olds (AQHA Challenge enrolled horses preferred)</p>
<p><b>RACE TRACK CHAPLAINCY OF AMERICA STAKES</b> \$35,000 guaranteed – 400 yards Fillies and Mares – 3-Year-Olds &amp; Older (AQHA Challenge enrolled horses preferred)</p>
<p><b>AQHA YOUTH RACING EXPERIENCE STAKES</b> \$35,000 guaranteed – 870 yards 3-Year-Olds &amp; Older (AQHA Challenge enrolled horses preferred)</p>

## UNDERCARD PREFERENCES:

### First Preference

Racing Challenge-enrolled horses that finished second, third or fourth in a Regional Challenge Final run under the same conditions by order of finish and then by Challenge money earned during the current calendar year through midnight on the day of the last scheduled Regional Challenge Final. However, as stated above, if a horse has qualified to a Racing Challenge Championship Final and receives a berth in that final, the horse is considered a Racing Challenge Championship qualifier for the undercard entry purposes and is therefore ineligible for an undercard race.

### Second Preference

Racing Challenge-enrolled horses that ran in a Regional Challenge Final by order of finish then by Challenge money earned during the current calendar year through midnight on the day of the last scheduled Regional Challenge Final.

### Third Preference

Challenge enrolled horses that ran in a Challenge trial by Challenge money earned then any Challenge enrolled horses that did not run in a regional trial or final by money earned through the last scheduled Regional Challenge Final.

### Fourth Preference

Any non-Challenge Enrolled horse by money earned during the current calendar year through midnight on the day of the last regularly scheduled Regional Challenge Final with a **\$250** time of entry fee. This fee is solely for entry into the said race and does not constitute eligibility to future Challenge races. All horses must be nominated to the race according to the conditions set forth herein and have fulfilled the required condition of entry hair testing.
