## SPECIAL NOTICE

The rules of racing adopted by the Texas Racing Commission and Lone Star Park at Grand Prairie ("Lone Star") govern all races run at Lone Star. Nominations to this stake are received only with the understanding that association reserves the right to refuse the nomination without notice to the subscriber. No nomination will be received except upon this condition. All disputes, claims and objections arising out of the race or with respect to the interpretation of the conditions of any stakes shall be decided by the association or those whom they may appoint and their decision upon all points shall be final.

Lone Star reserves the right to divide the races in any manner advisable with the total purse under these conditions divided proportionately, to reduce the amount of added or guaranteed money, or to cancel this stake at any time prior to the running thereof, without liability except for the return of the nomination and entry fees.

Nominations are made with the understanding that said nomination does not assure stall space for horse nominated. Application for stable space must be made to and approved by the Lone Star stall committee.

Earnings as reported by Equibase will be used when determining the preference of horses based on earnings.
The maximum number of starters in any race shall be limited to the number of starting positions afforded by the Lone Star starting gates.
In nominating for the stake, subscriber assumes all risk of loss, damage or injury to persons, animals or property employed, owned or used by subscriber on Lone Star premises and releases Lone Star from all such claims whether arising from negligence or otherwise.

Subscriber, for himself, his agents and his employees hereby assign to Lone Star any and all right to motion pictures, television and radio broadcasting in connection with this race.
Scheduled payments are subject to 3 day grace period for mailing with a postmark and 7 day grace period to be delivered. Lone Star is not responsible for mailing delays.
Time Trials: Each time trial shall consist of no more than ten (10) horses. The time trials shall be raced under the same conditions as the stakes. If time trials are held on the same day, the ten (10) fastest times qualify to start in the finals. If time trials are held on two (2) days, horses with the five (5) fastest times on the first trial day and the horses with the five (5) fastest times on the second trial day qualify to start in the finals.

Horses qualify on the basis of time and order of finish in time trials. The finish times of horses in trial races are determined only to the thousandth of a second. The sole exception of the preceding is when two (2) or more horses have identical times in the same trial race, then order of finish shall also determine preference in qualifying for the finals.

Should two (2) or more trial horses have the same qualifying time (to the thousandth of a second) for the finals, a draw by random lot shall be conducted under the auspices of the Board of Stewards. Under no circumstances shall a horse qualify that was placed by order of finish behind another horse, except due to disqualification.

During the running of time trials, should a horse be disqualified due to interference, it shall receive the time of the horse it is immediately placed behind plus one-thousandth ( 0.001 ) of second.

No change will be made in the recorded times of time trials to account for head, tail \& cross winds, track condition, etc. Should the electronic timer device malfunction during any time trial, finalist from that particular trial race will be determined by official hand timing. Hand timing will be conducted by three (3) reputable and disinterested persons. The average of three times will be used on the winning times, unless one is clearly wrong, then the average time will be based on the two (2) remaining times.

Also-eligible: There will be no also-eligible list for the finals. If a disqualification arises prior to entry date for the final due to a positive post race test or ineligibility of a horse due to a rules violation, the next fastest qualifier shall move into the finals.

Any horse which ran in the trials and didn't qualify for the finals will remain eligible to the Dash for Cash Juvenile Stakes. There must be at least 100 entries in the trials in order for there to be a Dash for Cash Juvenile Stakes.

Preference will be given to horses based on their times in the Futurity Trials. Ten percent (10\%) of the futurity gross purse will be set aside for the Juvenile Stakes. Futurity finalists are not eligible for this race.

Purse Distribution: Finals: $40 \%$ to first, $17 \%$ to second, $10 \%$ to third, $7 \%$ to fourth, $6 \%$ to fifth, $5 \%$ to sixth, $4.5 \%$ to seventh, $4 \%$ to eighth, $3.5 \%$ to ninth and $3 \%$ to tenth. Juvenile Stakes Payout: $25 \%$ to first, $20 \%$ to second, $15 \%$ to third, $10 \%$ to fourth, $8 \%$ to fifth, $7 \%$ to sixth, $6 \%$ to seventh, $4 \%$ to eighth, $3 \%$ to ninth and $2 \%$ to tenth.

Scratches: If due to a rule violation, a horse is ruled ineligible by the stewards or the Texas Racing Commission for entry in any of the races or if the stewards scratch or disqualify a horse from any of the races described herein due to a rule violation, such horses will be ineligible for receipt of any purse money. In the case of the finals, the purse money that might have been due to such horse will be divided proportionately among the other starters in the race in accordance with the purse distribution percentages. If a horse that has qualified for the final should be unable to enter the final due to racing soundness (i.e. injury or bleeding) the horse shall receive last place purse money. If a horse is withdrawn from the finals for any reason other than a rule violation, the owner of such horse or horses scratched will receive last place purse money. If a horse is withdrawn from the Juvenile Stakes for any reason, the owner of such horse or horses will receive no purse monies. Any remaining purse money payable with respect to such horse will be distributed to the winner of the Juvenile Stakes.
