**FOR ARABIAN THREE YEAR OLDS AND UPWARD** No nomination fee. \$250 to enter and an additional \$250 to start with \$30,000 Added. Supplemental Nomination payment of \$1,000 is due at the time of entry and includes all fees. The Added monies and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 6% to fourth, and 4% to fifth after sixth thru tenth are paid \$1,000 each. If less than ten horses start, the purse monies not awarded will revert to the winning owner. Weights: Three Year Olds, 122 lbs.; Older, 124 lbs. Non-winners of two races in 2025 allowed 2 lbs.; a race in 2025, 4 lbs. (Claiming races not considered in allowances). Starters to be named through the entry box by the usual time of closing. Preference given to original nominations with the highest earnings in 2024-2025. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of their entry fee. A trophy will be presented to the winning owner.
