### TO ENTER:

1.1. – Interested players may enter in person the day of the event, or online for some events. Interested players may visit [www.LoneStarPark.com/Handicapping-Tournaments](http://www.LoneStarPark.com/Handicapping-Tournaments) for more information specific to each tournament. Limit three entries per person for all Live Money-format tournaments. Entries may be capped in tournaments; details for each tournament can be found online.

1.2. All players must be at least twenty-one (21) years of age on or before the day of the tournament.

1.3. Players are required to fund their own “live” bankroll. Deadline for funding via check is four days prior to event. Deadline for funding via cash is day of contest. The bankroll amount for live money tournaments vary, and will be posted online. The bankroll belongs to the player, and any monies (winnings or leftover funds) can be withdrawn by the player once it has been deemed by officials “okay” to withdrawal; usually within 15 minutes after final contest race has gone official. The player’s bankroll cannot be funded via credit card; only cash, check or money order will be accepted.

### 2. HOW TO PLAY:

2.1. The tournament will begin with an “early race period”, which consists of wagering at least the amount of your starting bankroll on your choice of race(s) from the designated list of eligible races. No specific races will be mandatory during the “early race period”. Participants are required to wager at least a minimum of their starting bankroll during the “early race period” and may continue to wager with winnings beyond that. Failure to wager at least the amount of their starting bankroll during the “early race period” will result in a disqualification in the tournament. Eligible wager types include Win, Place, Show, and Exacta wagers (no multi-race, trifecta, superfecta or super hi-five wagers are eligible). After the “early race period” has concluded, the tournament will then progress into a “late race period”. The “late race period” will consist of all players required to wager a total of at least half (50% or more) of their current bankroll balance, established at the conclusion of the “early race period”, during the “late race period”. If a player’s bankroll is below the amount of the initial starting bankroll amount, then they must wager at least half (50% or more) of the initial starting bankroll amount or “all in” during the “late race period”. The “late race period” will be races designated by Lone Star Park officials. No specific races will be mandatory during the “late race period”. There is no cap placed on mutuel payouts. If a race is cancelled for any reason, tournament officials have the option to select an alternate race. The player with the largest bankroll balance after the final race will be declared the winner of the tournament. Balances can be withdrawn by the player once it has been deemed by officials “okay” to withdrawal; usually within 15 minutes after final contest race has gone official.

\*Current NHC Tour membership is required to earn a seat to the NHC. Non-Tour members are ineligible to participate in tournaments where NHC seats are the only prize available.

4. Wagers are limited to the following wager types: Win, Place, Show, and Exacta wagers (no multi-race, trifecta, superfecta or super hi-five wagers are eligible). Official program numbers from the Lone Star Park at Grand Prairie program must be used for all wagers. Players must make their wagers at any of the “Red” self-serve machines. It is the player’s responsibility to ensure that their wagering activity is accurate, as prizes will be awarded based on the horses selected through the Tote system and official mutuel payoffs.

5. The player must log in to their given tournament account at the “Red” self-serve machines as well as select the name of the track, race number and horse they wish to wager along with bet type and denomination. Each player is responsible for the accuracy of his or her wagers.

6. Wagers will only be accepted at the “Red” self-service machines. **IT IS THE PLAYER’S RESPONSIBILITY TO CONFIRM ACCURACY OF THEIR WAGERS.**

7. All mutuels for this tournament will be verified by the Tote system. In all cases, the official mutuel payouts according to the Lone Star Park at Grand Prairie Tote system will be considered official and final.

8. **SCRATCHES:** If a horse is scratched after a wager is placed, it is the player’s responsibility to change his or her selection prior to the start of the race. If a wager is not cancelled and the race goes off, the player will collect a refund or partial refund if applicable. A player may revise or cancel a bet at any time prior to the post time of that race. Late scratches may occur; **A SCRATCH WILL NOT EXEMPT A PLAYER FROM WAGERING THE REQUIRED AMOUNTS.**

9. In the event a player does not make the required wagers, wagers on any ineligible race(s), places any ineligible wager type, or does not wager enough, they will be disqualified from the tournament. A player may cancel any “mistake wagers” without penalty. A “Clean” Score Card is required to win any prizes.

10. Players must place all wagers personally. The entrant whose name appears on the official entry form and lanyard must place all wagers. No person shall directly or indirectly act as an intermediary, transmitter, or agent in placing wagers for the entrant. Photo ID will be required at Tournament Check-In.

11. Standings and winners will be determined by player’s bankroll balance on the day of the Tournament, pending verification that all wagers were made in accordance with tournament rules.

#### 12. TIEBREAKERS

In the event of a tie for a place with a prize, the tie will be broken on the following basis: (1) The winner will be to the player with the highest amount wagered. (2) In the event of a further tie, the player with the highest single mutuel payout will be declared the winner. (3) In the event of a further tie, the player with the next highest single mutuel payout will be declared the winner. Should a tie still exist after all previous tie-breaking methods are exhausted, prize money shall be divided equally. In the event of a tie involving places with NHC seats or BCBC Seats, the tie shall be decided by coin flip after above methods have been exhausted.

13. All players are responsible for ensuring each wager is placed correctly. Please follow the instructions in these official rules.

14. The bankroll belongs to the player, and any monies (winnings or leftover funds) can be withdrawn by the player once it has been deemed by officials “okay” to withdrawal; usually within 15 minutes after final contest race has gone official. If a player is found to have either deposited money at any time (other than the initial deposit) or withdrawn money prior to officials declaring it okay to do so then that player will be disqualified. Any player that has been disqualified from the tournament for any reason is able to withdrawal their bankroll at any time. Any player who chooses to withdrawal their bankroll before officials have declared it okay to do so are free to do so and agree that they will be disqualifying themselves for the purposes of the tournament prizes if they do so.

15. **HORSEMEN (OWNERS):** Any horse owner competing in a tournament must declare with a tournament official if he/she has a runner entered into an eligible tournament race. The horse owner shall agree to not wager on any race where they have a runner entered. **ALL OTHER LICENSED HORSEMEN:** Any TXRC licensed horseman, other than owners, are ineligible from competing in tournaments that contain Lone Star Park as the only eligible track for tournament play. Anyone licensed is eligible to compete in tournaments that offer simulcast tracks, but must skip all races from Lone Star Park (if applicable) and must declare with tournament officials if he/she has a runner entered into an eligible tournament race from a simulcast track. The horseman shall agree to not wager on any race where they have a runner entered.

16. Players must arrive and begin playing no later than post time of the last scheduled race in the “early race period” or be subject to disqualification.

17. In the case of a Tote malfunction: In the event that the tournament tote system experiences a loss in the data at any point and less than five (5) races were wagerable, including at least one (1) race from the “Late Race Period”, the tournament will be cancelled and rescheduled. In the event that five (5) or more races were wagerable, including one (1) or more “Late” race, the day’s tournament will be declared official.

18. Contestants must be 21 years of age or older on or before the tournament date, to participate. Employees of Lone Star Park at Grand Prairie and its advertising agencies, or any members of the immediate families of the foregoing and any individual admitted to Lone Star Park at Grand Prairie free of charge due to employment on Lone Star Park at Grand Prairie property are not eligible to participate in any of the tournaments. Liability for any and all federal, state and local taxes rests solely with the prizewinners. Anyone winning \$600 or more must sign a release form, confirming compliance with these rules and regulations of this contest, and fill out a W-9 form for tax purposes. Note: Eligibility (e.g., employment or affiliation, family relationship, past winnings,) may vary between the qualifying tournaments, however, eligibility of finalists for the Breeders' Cup Betting Challenge shall be established by Breeders' Cup Limited and shall apply to the Breeders' Cup Betting Challenge event; and eligibility of finalists for the National Horseplayers Championship shall be established by NTRA and shall apply to the National Horseplayers Championship event.
19. Lone Star Park and all contestants release and hold harmless the racetracks owned, operated or represented by Churchill Downs Incorporated from any liabilities, claims, demands, damages and costs arising from this contest.
20. Each of the NHC Seat or BCBC Seat winners must be in attendance at the event on each day of the event. If one of the winners cannot attend, the next highest placing individual from the applicable tournament will earn a berth to the event. Depending on a particular situation, Lone Star Park, in cooperation with the NTRA or Breeders Cup, may assign an alternate. By participating in this contest, all players agree to abide by these determinations. All hotel accommodations for NHC seats will be arranged by the NTRA and paid for by Lone Star Park at Grand Prairie for the individuals representing Lone Star Park at the NHC (travel costs for spouses, guests and/or significant others traveling with the individual will be the responsibility of each individual player). Airfare or the equivalent (ie: Airline Gift Card) will be awarded at a value of \$500 to each individual going to the NHC, paid for by Lone Star Park at Grand Prairie. Not all airlines offer gift cards but best efforts will be made to accommodate preferences for those traveling to the NHC. Participants agree to travel according to the accommodations provided by Lone Star Park. Winners of BCBC Seats do not receive hotel accommodations or airfare for travel; all travel to the Breeders' Cup Betting Challenge event is at the responsibility of each individual player.
21. Players must be NHC Tour Members in order to be eligible to compete for NHC Seats. NHC Seats will be awarded in order of finish from those that are current NHC Tour members and to those that are not already double-qualified for the NHC. NHC Tour membership must be established and/or current at the beginning of the tournament.
22. In tournaments with BCBC or NHC Seats available, all tournament participants will receive complimentary admission, valet parking, seating, Food and digital past performances. Alcoholic beverages as well as anything else not previously mentioned are not complimentary.
23. Players shall receive credit in the Star Player Rewards program for wagers made in tournaments with a buy-in of \$300 or more and those points shall take up to four weeks to be processed.
24. Withdrawal of funds in player's tournament account at conclusion of contest is the responsibility of the player. Funds not withdrawn by player will convert into the form of a Mutuel Voucher. Player agrees to forfeit their voucher if it goes unclaimed for 365 days (the expiration period for Mutuel Vouchers). In order to claim your voucher, please contact the Lone Star Park Mutuel Office before expiration of voucher.
25. A Player must participate in any tournament in which their entry was awarded as a prize from either a qualifier, a feeder or a third-party contest. Failure to participate will result in forfeiture of prize. "Participating" is defined as having wagered the initial full bankroll amount won.
26. A participant is allowed to earn up to Two (2) NHC Seats in total and/or Two (2) BCBC Seats in total as well as both of them from Lone Star Park, but only One (1) 'Major Prize' (defined as either a NHC Seat or BCBC Seat) per event. Any participant that happens to have multiple entries from any one event finish in places that both award NHC Seats/BCBC Seats will only receive One (1) NHC Seat or One (1) BCBC Seat from that event.
27. Lone Star Park at Grand Prairie, through its management, reserves the right to interpret all questions and conditions in regard to this event, without claim for damages or recourse of any kind.
28. All questions not covered in these rules will be decided by the management of Lone Star Park at Grand Prairie, its decision to be final.
